PRIVATE LANE SNOWPLOW POLICY

The Rural Municipality of Mountain may provide snowplow services for residents of the Municipality. Terms and conditions of such services are defined by this policy.

Terms and Conditions

- 1. Prior to grant snowplowing services, the local Councillor shall determine if any local concerns would affect the decision.
- 2. An application for snowplowing services is to be filled out, along with payment, and submitted to the Municipal Office prior to October 31st of each year. Requests after this date may be considered and will be subject to a \$100.00 late fee.
- 3. The price payable annually shall be set as follows:
 - a. Short Driveways (1,000 feet or less) \$300.00
 - b. Long Driveways (1,000 feet or more) \$600.00
 - c. Driveways that are not adjacent to the normal operating route of the municipal contractor shall be charged the rate above plus an additional \$80.00 per kilometer from the normal operation route. Kilometers will be rounded up to the nearest whole kilometer. (For example: A short driveway 5 kilometers from the normal operation route would be charged a rate of \$700.00. \$300.00 for the short driveway plus \$400.00 for the additional mileage rate)

In making application to the Municipality for snowplowing services, the resident will agree to:

- 1. That requests for plowing must be made to the Municipality and not the Contractor completing the work. Any concerns or dissatisfaction with works completed shall also be made to the Municipality not the Contractor.
- 2. This service is provided when the equipment is in the area and is not made on request.
- 3. That gates that are closed or roadways that are blocked will not be plowed.
- 4. This service includes the snowplowing to the residence and does not include outbuildings or other plowing requests.
